### Updates


• We achieved record total index derivatives volumes during March of 8,307 lots, beating the previous record of 6,574 set in March 2023. This included record monthly index futures volumes of 8,303, beating the previous record of 5,971 set in March 2023.

 CEDX broadened its range of equity options on March 25 and now offers options on more than 300 companies from 14 European companies. View the full list of underlying stocks here.

 On 1 April, we initiated the first Liquidity Provider Programme (LPP) for single-stock options, which also applies to index options, and is available **here**. We also revamped the **LPP** for index futures, extended the Volume Incentive Programme for these products through to the end of March 2025 and initiated a new Strike Creation Policy.
